# Memorandum

With the fall temperatures fluctuating, we have made last minute adjustments to our visit schedules over the past few days – thank you for your patience and understanding. Because the weather is supposed to be nice over the coming days, we are offering Outdoor Patio Visits on November 6, November 9 and November 10. Please find the schedule for visits on the second page of this memo. Our team has added an additional area for window visits in the Multi-purpose Room on the Terrace Level so that more visits can be accommodated. Instructions on parking and accessing that section of our campus will be included in the SignUpGenius email that will be sent with the visit confirmation email.

As we continue through our Path Forward plan, we are collaborating with both the Montgomery County and Maryland Departments of Health. With their guidance, we have been authorized to return to communal dining and small group programming for residents in all levels of care, while taking the appropriate precautions. While the dining rooms are arranged to support social distancing, the residents have thoroughly enjoyed being back in the dining rooms seeing each other, even if from a distance! Assisted living residents have two meal seatings for both lunch and dinner to accommodate social distancing requirements.

We are continuing our universal weekly testing for both residents and team members, and this week's results were all negative. Once we complete our 14-day time period since our last positive team member test, we can apply for additional opening privileges, which could include opening for indoor visits.

We recognize the importance of salon services and are currently working through a plan that will allow limited salon services to return to at The Village at Rockville. We will be sharing updates with families in future community updates.
