Subject: Health Center Path Forward Update

We were so glad to resume indoor visits this week! Seeing residents reunite with their families is heartwarming to watch in a normal season. It is especially wonderful to see now as we continue to weather the pandemic. Seeing these visits take place is a harbinger of hope that soon we can continue to open our community to other members of the public.

This week we continued on our due diligence road, following Maryland Department of Health and CMS guidelines. We completed testing of residents last week and are proud to report that there are no positive tests amongst residents. All team member tests were negative this week as well. We completed one test per team member. This test was a PCR (lab) test for team members and routine care partners. If all team member test results received by Monday of next week are negative as well, we will have exhausted our 14-day waiting period and will be out of outbreak status.

We have also continued practicing infection control protocols by properly using personal protection equipment, washing hands, and disinfecting high-touch and common areas.

As we finished our third COVID-19 vaccine clinic on Wednesday, March 24, we are pleased to report that at this point our community is achieving herd immunity. Our vaccination statistics are as follows:

- 95% of independent living residents are vaccinated
- 95% of assisted living residents are fully vaccinated
- 96% of long term care residents are fully vaccinated
- 70% of short term care residents are fully vaccinated
- Approximately 65% of our team members are fully vaccinated (A Washington Post-Kaiser Family Foundation poll recently released reported that 52% of health care workers had received their first dose of the COVID-19 vaccine.)

While we thought Wednesday was our last vaccination clinic, we have just been informed of an additional opportunity for residents and team members to be vaccinated.

The Maryland Department of Health (MDH) reached out to The Village at Rockville to make a vaccine opportunity available to residents and staff. They have been given a limited supply of Johnson & Johnson vaccines for those who have not been vaccinated. The Johnson & Johnson vaccine is a single dose vaccine. (MDH will <u>not</u> be giving Moderna or Pfizer vaccines.) Residents and team members who wish to be vaccinated should contact Healthcare Administrator Erin Wheeler by **Monday, March 29 at 11 a.m.** at 301-354-8423. MDH will provide a date/time for vaccine once finalized.

We are so thankful to residents and team members for their commitment to care for each other through acts of vaccination during these times.

The indoor visits schedule has been posted for April for our families to sign-up. Indoor visits will continue in the Chapel during the month of April. As a reminder:

- All visits must be scheduled in advance: <u>https://www.signupgenius.com/go/indoorvisits</u>
- Visit appointments are available five days in advance. The sign-up locks one calendar day in advance and no additions can be made after that time.
- Visits are limited to one visit per week with no more than two visitors per visit
- 3 Virginia residents or residents under isolation precaution are not eligible for in-person visits.
- The indoor visits schedule is as follows:
 - Tuesdays: 10 a.m. to noon, 3-5 p.m.
 - Thursdays: 10 a.m. to noon, 4-5 p.m., 6-6:30 p.m.
 - Saturdays: 10 a.m. to noon

Virtual visits remain an option for residents and families to connect. Consider signing up for a virtual visit as well as an in-person visit so that you can "see" your loved one twice this week.

Also, don't forget to make your salon appointment, as you may want a new look for spring. We have adjusted to one-hour time slots to meet the service needs of residents, as well as completing infection control cleaning practices following each appointment. Residents may sign up for one appointment per week.

Second and third floor: Wednesdays and Fridays Appointments can be made at <u>www.signupgenius.com/go/tvarsalon</u> or by calling 301-424-9565 or extension 11000. Currently, 3 Virginia residents or residents under isolation precautions are not eligible for in-person visitation.
