The month of May is already off to an incredible start here at The Village at Rockville—A National Lutheran Community. Residents across the Health Center enjoyed an exciting Cinco de Mayo celebration featuring a live mariachi band. Our ConnectedLiving team is gearing up for exciting Mother's Day celebrations this weekend, and residents and families continue to visit together. It feels like the month of May will provide us with several exciting steps on our path forward journey.

We continue to receive negative test results among residents and team members, so we have shifted our focus to providing the COVID-19 testing monthly to non-vaccinated team members. This frequency is based on the Montgomery County COVID-19 positivity rate and updated testing guidelines provided from the Maryland Department of Health (MDH). POC (rapid) tests are completed for non-vaccinated team members. We will continue to keep you updated regarding test results.

We also appreciate your support with all of the changes we communicated last week according to updated guidance from the Centers for Disease Control (CDC) and the MDH. As a reminder, if you are visiting your loved one in the Health Center, you may not walk through the hallways and common spaces (including Lang Hall). Please utilize the options of visiting your loved one in their apartment, or going directly outside for your visit. As always, please follow proper social distancing protocols, masking and hand hygiene. Residents and resident family members who have been fully vaccinated may remove their masks in their loved one's apartment, however social distancing is still encouraged.

It is so nice to see residents enjoying meals with each other with greater regularity. Fully vaccinated residents can enjoy meals and programming with each other without social distancing. When residents who are not fully vaccinated join, all residents should wear masks and social distance.
