## Memorandum

This week brought new news for the state of Maryland. As of July 1, Governor Hogan is ending the COVID-19 State of Emergency. As a result, masks are not required in any public venue across the state. While this is great news, it **does not apply** to residents living in the Health Center at The Village at Rockville. The Maryland Department of Health (MDH) has not changed their requirements for health care settings. Therefore, keep masking, practicing healthy hand hygiene, and social distancing while visiting at The Village at Rockville. The only exception to this rule is that fully vaccinated residents and fully vaccinated family members visiting the Health Center may remove their masks when visiting in the family member's room. As always, team members will remain masked throughout the community. While we anticipate that one day we will be able to remove masking from our set of guidelines, we are not there yet, and appreciate everyone's diligence adhering to this guidance as we move forward.

We are also excited to note that our vaccination rates continue to increase throughout the community. Following are our current vaccination statistics:

- 83% Skilled nursing team members
- 90% Assisted living clinical team members
- 92% Skilled nursing residents
- 97% Assisted living residents

As visitation times have increased to **three times** per week, we ask that families coordinate so that visits do not fall on the same day of the week. Also, thank you in advance for going directly to your loved one's room or outside instead of walking around the Health Center. Please note the following visitation days according to resident location: .

- Second floor: Tuesday, Thursday, Saturday
- Third floor: Monday, Wednesday, Friday, Sunday
- Assisted living: Monday, Wednesday, Friday, Sunday
